

Write & Cite® is designed to give learners the skills needed to write, format, and properly cite academic papers and dissertations. In addition, the module provides instruction on proper word choices, tone, paper organization, literature-based research, and techniques to avoid plagiarism. If you are required to complete Write & Cite® by your school or institution, this document will guide you through the registration process and answer some frequently asked questions.

### Assignment Link Registration Process:

Many colleges and universities choose to integrate Write & Cite into the course shell of their Learning Management System (LMS). There are several different types of LMS systems including but not limited to: Blackboard, Canvas, D2L/Brightspace, Moodle, Sakai, and more. How you gain access to your assignments will vary for all universities. Below is a general guideline as to how you might gain access to your Write & Cite module:

- Please follow the instructions provided by your instructor or course syllabus. The Write & Cite link will be embedded into one of your weekly assignments. You will need to locate the week that the link has been placed.
- Please click the access link that is included in the assignment.
- You will be prompted to confirm your name, student ID, program, as well as other possible identifiers that your school may choose.
- Once you have filled out the required fields, please click **“Confirm”** to start.

- Launch the module by clicking **"Please click here to launch your course/exam in a new window."** You will read through a series of acknowledgment screens and check each box once you have read the information. You will then be ready to begin the module.

**What are the overall structure and time constraints of the Write & Cite: Academic Writing Readiness module?**

- 8 sections make up the Write & Cite module. Each section will provide lessons on multiple topics with specific learning outcomes. The module will teach APA, MLA, or CMS documentation styles depending on the Write & Cite version that your institution requires you to take. The module will also provide instruction regarding word choices, tone, paper organization, literature-based research, and techniques to avoid plagiarism.
- Each module starts with a 20-question pre-test, which must be completed prior to starting the instructional material. The pre-test is designed to capture your baseline knowledge and does not require any preparation. You will receive one question at a time, and the questions are timed.
- Each section will conclude with a Section Quiz of 5 questions. To advance to the next section, you must answer at least 3 questions correctly.
- After you complete all eight sections, you can proceed to the 50-question competency exam or post-test. The post-test is cumulative and covers all the sections. If you are not satisfied with your original score or do not meet the minimum score threshold set by your school, you may elect to retake the post-test. In the event of a retake, your *highest score* will be recorded.
